THE 94TH ALL AMERICAN CONTEST

The All-American Program recognizes the outstanding animals exhibited at State, Regional and National shows during the current calendar year. The option to enter online is available, as well as submission of ALL information to the Purebred Publishing office at 1224 Alton Darby Creek Rd., Columbus, OH 43228

For the 2018 show season, the All-American competition will consist of the following Classes:

Spring Heifer Calf (born on or after 3/1/18 and is 4 months of age)

Winter Heifer Calf (born 12/1/17 thru 2/28/18)

Fall Heifer Calf (born 9/1/2017 thru 11/30/2017)

Summer Yearling Heifer (born 6/1/17 thru 8/31/17)

Spring Yearling Heifer (born 3/1/2017 thru 5/31/17)

Winter Yearling Heifer (born 12/1/16 thru 2/28/17)

Fall Yearling Heifer (born 9/1/16 thru 11/30/16)

Yearling in Milk (born on or after 9/1/16)

Junior Two Year Old Cow (born 3/1/16 thru 8/31/16)

Senior Two Year Old Cow (born 9/1/15 thru 2/29/16)

Junior Three Year Old Cow (born 3/1/15 thru 8/31/15)

Senior Three Year Old Cow (born 9/1/14 thru 2/28/15)

Four Year Old Cow (born 9/1/13 thru 8/31/14)

Five Year Old Cow (born 9/1/12 thru 8/31/13)

Aged Cow (born before September 1, 2012)

150,000 Lb. Cow

Produce of Dam (Group to consist of two females, any age, that are maternal sisters.)

Jr. Best Three Females (Group to consist of three females born on or after September 1, 2016 which have not yet calved. Each must have been bred, all or in part, by its exhibitor and at least two must be owned, all or in part, by its exhibitor)

Sr. Best Three Females (Group to consist of three females, two milking age, one any age, all to have been bred, all or in part, by their exhibitor and at least two must be owned, all or in part, by their exhibitor.)

Note: A cow qualifying in a dry cow class is eligible for competition in her respective standard class providing the picture represents her in the same show ring condition as when she qualified.

Yearling heifers that have freshened and are shown in milk, must be entered in the Yearling in Milk class. Animals may qualify for entry in this class on the basis of their placings in a milking class and/or as an unfreshened heifer earlier in the season.

An animal must qualify in the 150,000 lb class and list only the placings from the class entered in the contest. In no case will the same animal be eligible for the 150,000 lb. class and aged cow class in the same year.

Individual photos of each of the three animals in the group should be submitted for the Best Three Female classes and taken during the current show year.

PICTURES - It shall be the responsibility of the exhibitor to secure and supply the pictures of the animals being entered in the All-American contest.

It is encouraged that ALL photos be submitted electronically either from the professional photographer or owner to allamericanentry@gmail.com.

PICTURES MUST BE RECEIVED BY PUREBRED PUBLISHING BY NOVEMBER 25.

Failure to supply photo by deadline will result in dismissal from the contest and forfeiture of all fees.

ALL PHOTOS must be a professional photo taken by a livestock photographer that is an unretouched color glossy print digital or 5x7 hard copy. ON THE BACK MUST BE NAME, REGISTRATION NUMBER AND DATE TAKEN. Pictures must be taken during the current year and show the animal in the same stage of growth and/or lactation as when making the qualifying show ring appearance. Pictures will remain at Purebred Publishing after the contest and be used for any promotional purposes.

Junior Entries should email or send photos of owners for publication with the results.

ELIGIBILITY:

An animal must place:

1 – 12 at International Show or

1 – 10 at 10 US National Holstein Shows (Midwest, Northeast, Southern, Midwest, &, Western Spring shows; Midwest Summer Show; Midwest, Western, Northeast, Eastern & MidEast Fall Shows)/ Jersey – Harrisburg, Louisville, Western National and the Royal or

1-3 at any show in which 150 Holsteins or 100 Jerseys are shown in US. Results must be submitted to Purebred Publishing by November 1. (Contact show management to ensure they are sent to Purebred Publishing by November 1) or

1st place at State Holstein Shows, Regional Shows & State Fairs in the US. Results must be submitted to Purebred Publishing by November 1. (Contact your show management to ensure that they are sent to Purebred Publishing by designated time.)

All-American Group Class Entries in the Open All-American contest will be accepted as shown in the ring. Therefore, any entry that is qualified and placed at a show will be eligible for the contest in the class. (Show placings MUST be sent to Purebred Publishing by November 1 from show management to be verified.)

Exhibitor must be in good standing with Purebred Publishing

ing, housing or any other significant affiliation with animals. The junior nominating committee panel will consist of the 11 judges from the 11 junior shows.

JERSEY: The Jersey contest nomination committee for both open and junior will be the judges from Harrisburg, Madison, Louisville, Oregon Western National and the Royal along with any associates from those shows. Their votes will be handled the same as above and judges with animal affiliations in classes will be asked to refrain from judging those specific classes. **ROUND 2:** The Holstein nominees will then be submitted to a panel of judges from the leading shows across the United States, associates of the National Shows and the National Show judges again.

The Jersey nominees will be submitted to a panel of judges consisting of those judges, associates and judges from additional leading shows across the United States.

The selections from this second judging panel will be assigned the traditional point numbers: 1st choice – 7 points; 2nd choice – 3 points; 3rd choice – 1 point to designate the All-American, Res. All-American, High-Honorable Mention & Honorable Mentions of the contest. In the event of a tie, again, the animal with the most AA votes would be the designated winner and continuing the tie breaker with the second most RA votes and so on. High Honorable Mention will be 20 points or more, Honorable Mention will be 15-19 points.

COST & ANNOUNCEMENT:

A \$10 per entry charge will be implemented to enter the Holstein World All-American or Purebred All-American Jersey contest. Entries will be accepted online or via mail by November 15. A \$30 per entry late fee will be assessed between November 15 and November 25.

The Junior contests will remain free for entry. A photo of the owner(s) should be submitted for publication with results.

ALL Nominated animals in the contests will be presented in the February issue of the *Holstein World*. All entries selected as nominees in the open Holstein and Jersey contests will be required to pay a nomination fee of \$150. The fee will be waived if an ad of a half page or larger is placed in the February or March issue of the *Holstein World*.

An alternate nominee will be designated by vote in each class and if nomination fee is not paid within 10 days of notification, the alternate will be designated as a nominee. The All-American winners will be announced in the March issue of the *Holstein World*.

PEOPLE'S CHOICE SELECTIONS

Purebred Publishing will continue the tradition of a People's Choice contest as well as an All-American people's contest. It will be available for electronic judging at purebredpublishing.com and holsteinworld.com. The results for this contest will be published in the *Purebred Dairy Breeders' Magazine* available April 1 to subscribers!

ENTRIES

Entry form & copy of registration certificate will be required or attached on the online entry form. Animals may be entered via form or electronic online form available at purebredpublishing.com and holsteinworld.com. All open class entries will be charged **\$10 per entry** payable at the time of entry by credit card (online) or check made out to Purebred Publishing if hard copy is submitted. An electronic photo must also be sent to allamericanentry@gmail.com or submitted by a professional cattle photographer to Purebred Publishing by the due date. Any photos of entries not received by Purebred Publishing by the due date, will result in a disqualification of entries.

All show results must be listed on the entry form and will be verified from submitted show reports. Those shows listed, but that cannot be verified due to no submitted show reports, will be omitted from the information sent to the nomination committee.

ENTRIES MUST BE AT PUREBRED PUBLISHING BY NOVEMBER 15, 2018.

THE CONTEST PROCEEDURE:

HOLSTEIN: A nominating committee will consist of the 11 National Holstein Show judges. (in the event a judge is the official in two or more National shows, they receive only ONE vote) They will consider the photographs and placings of the animals for which an entry form has been received. They will submit their ranked selections to Purebred Publishing for tallying. In the event of a tie, the animal with the most number 1 votes would be the designated nominee. Judges will be asked to refrain from judging classes in which they have any ownership, breed-
